



REGISTRATION - TERMS & CONDITIONS FOR INDIVIDUALS

REGISTRATION DEADLINES

- Early-bird Registration fees will apply until Monday, 17 February 2020 midnight GMT+2.
- As of Tuesday, 18 February 2020, midnight GMT+2, the Regular registration fee applies for every new registration.
- After Tuesday, 5 May 2020 midnight GMT+2, and on site, the Late registration fee applies for every new registration.

CONFIRMATION

Upon completion of your online registration, you will be sent a confirmation by email. The confirmation is sent to the email address provided on the registration form and will show whether we have received your payment and will include an invoice.

PAYMENT CONDITIONS

All costs referred to, are in US Dollars (USD). All payments must be made in US Dollars; no other currency will be accepted. Full payment is due for the registration fees. No registration confirmation or invitation letter will be sent until the required payment has been received.

PAYMENT BY CREDIT CARD

The online registration platform is a secured site. In the online platform you can pay with credit card bank transfer until **26 June 2020**. VISA, MasterCard and AMEX are the only credit cards accepted. Please enter all relevant information on the registration form. Upon completion of the online registration process, you will receive a paid invoice (receipt) or a payment request as per bank transfer option by email.

INVOICE

Only digital versions of invoices will be sent to participants upon completion of the registration. The invoice will be issued using the contact details provided on the registration form so please make sure you have provided us with the correct information.

REGISTRATION MODIFICATION & CANCELLATION CONDITIONS

In the event of cancellation, written notification must be sent by email to woc@icowoc.org. The following refund conditions apply:

- For cancellations received up until **Tuesday, 5 May 2020 midnight GMT+2**, fees will be refunded less **US\$ 100** for administrative costs.
- For cancellations received after **Tuesday, 5 May 2020 midnight GMT+2**, the registration fee will not be refunded for cancellations or no-shows.

INVITATION LETTER FOR VISA APPLICATION

If you are unable to attend the congress because you were denied a visa, you will be granted a refund only if you submit a copy of your visa rejection letter and proof that you applied for a visa **no later than 27 March 2020**. Attendees requiring a visa are encouraged to apply as soon as possible.

Refunds will be processed 3-5 weeks after the congress. Without exception, all valid requests for refunds must be received in writing no later than 5 days after the end of the congress.
